Document order: Global ratings are followed by composites; each on a separate sheet. For the composites, a color change indicates a change in wording, while gray shading (empty cells) indicates the data wasn’t collected.

For MA only, the plan in 2008 is Secure Horizons Medicare Direct.

The timing of the distribution of surveys was adjusted, for surveys labeled 2005 and earlier, distribution was generally at the end of the year. For surveys labeled 2007 and after, distribution was in the beginning of the year. The gap between 2005 and 2007 does not represent 2 years. Note, no 2020 survey.
